The tax character of dividends and distributions declared by New Mountain Finance Corporation (the “Company”) for the calendar year ended 2015 is set forth below. For tax purposes, the Company is a regulated investment company (“RIC”) and reports the tax character of dividends and distributions you received for the calendar year 2015 in accordance with Subchapter M of the Internal Revenue Code of 1986, as amended.

For the calendar year 2015, dividends and distributions were classified as follows.

No portion of the dividends and distributions declared during the calendar year 2015 is eligible for treatment as Qualified Dividend Income or for the Corporate Dividends Received Deduction.

Dividends and distributions that were reinvested through the Company’s Dividend Reinvestment Plan are treated, for tax purposes, as if they had been paid in cash. Therefore, stockholders who participated in the Dividend Reinvestment Plan should also refer to the information as provided in the table above.
